### 1. Procedure Statement

The Carers (Scotland) Act 2016 came into effect on 1<sup>st</sup> April 2018.<sup>1</sup> The Act extends and enhances the rights of carers. The legislation helps ensure better and more consistent support for both adult carers and young carers. Education and training for carers is one of the areas included under part 6 of the Act.

There are currently estimated to be around 1.1 million unpaid carers in Scotland. This number has increased significantly due to the Covid-19 pandemic.<sup>2</sup> In 2018-2019, the Scottish Funding Council reported that there were 15,565 student carer enrolments across the 27 colleges in Scotland.<sup>3</sup>

Ayrshire College aims to provide an inclusive learning environment that is responsive to the needs of all students. We recognise that many of our students have to deal with the demands of caring for a friend or relative whilst studying, and we are committed to removing barriers to learning for students who have caring responsibilities.

The purpose of this procedure is to outline the measures that are in place at the College to identify and support students who have caring responsibilities.

# 2. Equality Statement

The College is committed to advancing and promoting equality and diversity in all of its activities and aims to establish an inclusive culture free from discrimination and based upon the values of dignity and respect.

The College recognises its duties under the Equality Act (2010) to prevent discrimination, including discrimination by association. In the case of student carers, discrimination by association could occur if a student were treated less favourably due to the protected characteristic (e.g. disability or age) of the person for whom they are caring.

# 3. Scope

The procedure covers all prospective and current students who have unpaid caring responsibilities. The procedure recognises the unique and specific individual needs of each student carer, and that caring responsibilities can fluctuate over time and in intensity.

The procedure does not cover students with parental responsibilities (unless for a child with a disability or support need as outlined in the definition above), or those employed in a caring capacity.

# 4. Definition

Ayrshire College endorses the Carers Trust definition of a carer, which states:

A carer is anyone who cares, unpaid, for a family member or friend who due to illness, disability, a mental health problem or an addiction, cannot cope without their support. <sup>4</sup>

# 5. Procedure

#### 5.1 Identification

Students are encouraged to declare their carer status during their time at the College. This is to ensure that the necessary support is made available to them.

Students can declare their carer status at any point in their student journey including at application and enrolment stages. Students also have the option to declare their carer status in their funding application. The College accepts the student's self-declaration as evidence of their carer status. Students are not required to provide any further evidence of caring responsibilities.

The College may also become aware of a student's carer status during school transition meetings or through communication with other external partners and local Carer Centres.

The College recognises that students may not be carers upon joining the College but may become carers at any point in their student journey.

When a student declares their carer status, this information is shared with the Student Experience Team who will contact the student to offer support.

#### 5.2 Named Contacts

The College has a named contact for student carers on each main campus. The named contacts are a first point of contact for any enquiries relating to student carers. They will liaise with curriculum teams and external partners, as required, to ensure that student with caring responsibilities have access to appropriate levels of support. Student carers may be directed to the named contacts at any stage.

#### 5.3 Internal Support Provision

The College is committed to supporting student carers to successfully complete their course and achieve their full potential.

All students who declare their carer status will be contacted by Inclusive Learning to arrange an individual needs assessment and agree a Personal Learning Support Plan (PLSP). This allows for the implementation of a range of flexible support recommendations, whilst ensuring minimal disruption to learning and adhering to academic standards.

A summary of the PLSP is shared with the curriculum team to ensure that staff are aware of the student's carer status. Curriculum staff should implement the support

recommendations, including any assessment arrangements, outlined in the PLSP summary.

Initially, some student carers may choose not to complete a needs assessment as they feel that they do not require additional support. In such cases, Inclusive Learning will continue to make contact with the student at key points in the academic year to offer support. Student carers can make an appointment to complete a needs assessment at any point in their student journey.

Student Services staff can also provide support to students on an ongoing basis.

#### Support may include:

- Orientation visits to the College
- Information on course choices and help with completing an application form
- Confidential information, advice and guidance to help support students with their carer role
- Referrals to student support services including counselling support and the College Liaison Officers
- Signposting to internal resources including the Wellbeing Hub and the Student Association's Student Carers Forum
- Regular 1:1 meetings and ongoing support
- Signposting to external organisations including local Carers Centres
- Support to apply for discretionary funds
- Support with progress and next steps

#### 5.4 Mental Health and Wellbeing Support

The College has a range of Mental Health and Wellbeing support services, which all students can access. Student carers should be made aware of the resources available including:

#### **Wellbeing Hub**

Students can access the Wellbeing Hub on MyLearning.

The Hub contains useful websites, local and national resources and self-help guides.

## 5.5 Flexible Attendance Support

Where possible, timetables will be issued in advance to student carers so that they can make necessary care arrangements.

The College recognises that student carers may not be able to attend academic activities in the event of late changes to timetables

If a student carer requires to take time off due to caring responsibilities, college staff will take steps, where possible, to ensure that the student has access to missed materials or rescheduled activities.

The College may also consider the following:

- Discussing flexible attendance and how support might be provided
- Allowing time out of study for an agreed amount of time if caring responsibilities are required
- Allowing authorised absences for periods of medical appointment, where the student carer is required to provide support
- Making arrangements for the student to catch up on missed classes, where possible
- Offering flexible deadlines for assessments

## 5.6 Funding Support

The Student Funding Team can offer individualised funding advice and assistance for Student carers and will aim to ensure income maximisation based on the student's individual circumstances.
