## APPENDIX B – Instalment Plans

The instalments will be paid monthly by standing order mandate.

Total Course Fees Due	Number of Instalments
Less than £200	Due in full at time of enrolment
Between £201 - £500	25% deposit at enrolment then 3 monthly instalments
Between £501 - £750	25% deposit at enrolment then 4 monthly instalments
Between £751 - £1,000	25% deposit at enrolment then 5 monthly instalments
£1,001 or greater	25% deposit at enrolment then 6 monthly instalments
